## **SECTION 4: First aid measures**

#### 4.1. Description of first aid measures

General information:

In case of adverse health effects seek medical advice.

#### 8.2. Exposure controls:

Respiratory protection:

Suitable breathing mask when there is inadequate ventilation.

Combination filter: ABEKP (EN 14387)

This recommendation should be matched to local conditions.

#### Hand protection:

Recommended are gloves made from Nitril rubber (Material thickness >0,1 mm, Perforation time < 30s). Gloves should be replaced after each short time contact or contamination. Available at laboratory specialized trade or at pharmacies / chemist's shops.

In the case of longer contact protective gloves made from nitrile rubber are recommended according to EN 374.
